Sir/Madam,

I am directed to say that the National Council of Educational Research & Training (NCERT) and the Central Board of Secondary Education (CBSE) have developed TAMANNA (Try And Measure Aptitude And Natural Abilities) - An aptitude test for Senior School Students to support students in making choices regarding educational/vocational courses as well as career-related decisions. It enables stakeholders to know the aptitude of students of Class IX & Class X. The test provides information on student's specific abilities which would help in making educational and career choices. The aptitude test was piloted by the Central Board of Secondary Education (CBSE) with around 17,000 students studying in classes IX and X in its affiliated schools across different parts of the country.

The details about use of aptitude test, dimensions measured in the test, construction and standardization of the test, administration and scoring and understanding the meaning of aptitude test scores are available in the following manuals:

- Test Booklet which contains items related to the seven dimensions, i.e., Language Aptitude, Abstract Reasoning, Verbal Reasoning, Mechanical Reasoning, Numerical Aptitude, Spatial Aptitude, and Perceptual Aptitude
- Guide for Teachers and Parents for administration, scoring and understanding the test scores
- Technical Manual which provides details of test construction and standardization

Two videos have also been prepared to familiarize school principals and teachers with different aspects of the aptitude test. Soft copy (PDF) of TAMANNA Aptitude Test and Videos are available on: <https://ncert.nic.in/tamanna/index.html>

TAMANNA Aptitude Test is optional for use by schools and respective State Governments to benefit the students.
