**Subject: - Regarding closing of Educational Institutions in Himachal Pradesh.**

In continuation to the Government of Himachal Pradesh, Revenue Department, Disaster Management Cell Order Number: Rev (DMC)(C) 20-2/2021-COVID 19-III-dated: 10<sup>th</sup> August, 2021 (Copy enclosed for ready reference) on the subject cited above.

In this context, it is again reiterated that:-

**“All Schools shall remain closed except residential schools from 11<sup>th</sup> August to 22<sup>nd</sup> August, 2021, however, teaching and non-teaching staff shall attend the School. Education Department shall frame SOPs for the residential schools for containment of COVID-19. On line classes shall continue.”**

It is therefore, directed to take further necessary action in the matter accordingly by following all the standing instructions/SOPs issued by the GOI, GoHP as well as this Department time to time.



**ORDER**

Himachal Pradesh Disaster Management Authority (HPSDMA), has considered the unprecedented surge in COVID-19 cases, high positivity rate and fatalities in the State from time to time, and in order to break the transmission chain of COVID-19 virus, has imposed certain restrictions in the State of Himachal Pradesh, which was last extended vide Order dated 22.07.2021 which is in effect till further orders with some restrictions and relaxations as an emergency measure.

And whereas, the situation of COVID-19 in the State has been reviewed it is observed that the number of COVID-19 active cases and positivity rate is increasing in the State and situation is still precarious. Consequently, certain precautions and restrictions are still required to contain the spread and resurgence of the pandemic, therefore, the undersigned in the capacity of the Chairman (SEC) in exercise of the powers conferred under section 22(2)(h) and section 24 of the Disaster Management Act 2005 and in continuation to the earlier State Executive Committee's Orders, hereby directs that:

1. All persons intending to visit State shall carry their COVID-19 Vaccine Certificate (double doses) or a negative RT-PCR test report not older than 72 hours or RAT negative report not older than 24 hours w.e.f. 13<sup>th</sup> August, 2021.
2. All schools shall remain closed except residential schools from 11<sup>th</sup> August to 22<sup>nd</sup> August 2021, however teaching and non-teaching staff shall attend the school. Education department shall frame SOPs for the residential schools for containment of COVID-19.
3. Inter-State, Inter-district & Intra-district movement of public transport buses (stage/ contract carriages) is now allowed to be operated with 50% of the registered seating capacity w.e.f. 13<sup>th</sup> August, 2021. For Inter-State public transport buses, Transport department shall frame mechanism for checking of RTPCR/ RAT/ Vaccine Certificate as mentioned at point no.1 so that only eligible passengers will board the buses.



All the Departments and Organisations of the Government, District Magistrates, and Police Officials and Local Authorities of the State are directed to ensure strict compliance with the directions of the SEC. District Magistrates, Superintendents of Police will take adequate measures to implement these orders with the support of all the PRIs and ULBs in letter and spirit.

**Penal Provisions:**

Any person violating these measures and COVID appropriate behaviour will be liable to be proceeded against as per the provisions of Section 51-60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

**This will come into effect from dates mentioned above and shall remain in force till further order. All other restrictions & relaxations shall remain same as per previous orders.**


