

As you are aware, Azadi ka Amrit Mahotsav is being celebrated to commemorate 75 years of India's Independence. Hon'ble Prime Minister has launched "Azadi ka Amrit Mahotsav" on 12<sup>th</sup> March 2021 and will continue till 15<sup>th</sup> August, 2023.

2. All State Governments/Union Territory Administrations have planned various events and activities for the celebrations which may require bulk purchase of National Flags. Hon'ble Prime Minister, in his "Mann ki Baat" on 25<sup>th</sup> July, 2021 also made an appeal to buy Khadi products and equated it to "public service" and "service to the nation".

3. Khadi and Village Industries Commission (KVIC) has geared up to meet the demand and scaled up the production of National Flags in all sizes (cotton & silk). Apart from the Khadi Bhavans, the National Flags can also be purchased from KVIC's e-portal [www.khadiindia.gov.in](http://www.khadiindia.gov.in) and the GeM portal.

4. I would, therefore, request you to issue necessary instructions to the concerned Ministries/Departments in your State/UT to purchase National Flags from KVIC only. National Flags are handmade by Khadi artisans with utmost precision and care meeting the BIS standards. While this will directly benefit lakhs of Khadi artisans engaged in making of National Flags; it will also help in checking use of flags made of plastic etc.
