**ORDER**

**WHEREAS**, taking note of the current situation of COVID-19 in the State, it is observed that though the number of COVID-19 patients daily mortality and positivity rate is declining, and the situation is improving, however certain precautions and restrictions are still required to contain the spread and resurgence of the pandemic;

**AND WHEREAS**, in continuation to this office order No. CBA-Relief-3(36)/2021- 24351-501 dated 06<sup>th</sup> September, 2021 and in compliance of order/directions issued by the State Executive Committee (SEC) vide order No. Rev (DMC) (C) 20-2/2021-COVID-19 dated 14<sup>th</sup> September, 2021 the undersigned in the capacity of Chairman DDMA Chamba in exercise of the power vested in me under section 34 of the Disaster Management Act, 2005 do hereby order that: -

All schools shall continue to remain closed, except residential schools further up to 21<sup>st</sup> September, 2021. Teaching and non-teaching staff shall continue to attend the school. For residential schools SOPs developed by the Department of Education will be followed to contain the spread of COVID-19.

The compliance of this order shall be ensured by the Senior Superintendent of Police, Chamba, all the Sub-Divisional Magistrates, all the Heads of Departments, Executive Magistrates and the Deputy Director Higher/ Elementary Education, Chamba, District Chamba.

Any person violating these measures and COVID-19 appropriate behaviour will be liable to be proceeded against as per the provisions of sections 51-



60 of the Disaster Management Act, 2005 besides legal action under Section 188 of IPC and other legal provisions as applicable.

**This order shall come into force with immediate effect in the entire territorial jurisdiction of Chamba District and shall remain valid till further orders.**



**ORDER**

Taking note of the present situation of COVID-19 active cases and positivity rate in the State, the undersigned in the capacity of the Chairman-State Executive Committee (SEC), in exercise of the powers conferred under Section 22(2)(h) and Section 24 of the Disaster Management Act 2005, and in continuation of earlier SEC orders, hereby directs that:

All schools shall continue to remain close, except residential schools further up to 21.09.2021. Teaching and non-teaching staff shall continue to attend the school. For residential schools SOPs developed by the Department of Education will be followed to contain the spread of COVID-19.

**Penal Provisions:**

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

This order will come into effect immediately and shall remain in force till further order and all other restrictions and relaxations shall remain same as per previous SEC orders.
