As you are aware, Akhil Vishwa Gayatri Parivaar, Shanti Kunj, Hardwar has been conducting "Bhartiya Sanskriti Gyan Pariksha" every year in the school/colleges, etc. of Himachal Pradesh with the active support of the Government of Himachal Pradesh.

This examination aims at inculcating the knowledge and spirit of Indian culture, ethos and value in the character and personality of school and college students. This examination is being conducted in more than 17 States and UTs of India every year, in which lakhs of students participate. As a part of conducting this examination, a nominal fees (Rs. 25/Rs. 30/-) is charged from the students and they are provided the specially prepared study/learning material from which the examination is taken. Generally, this examination, which is of one hour duration, is taken on any day in the month of October/November and no regular study-routine of the student is affected. The toppers in different categories are felicitated at an award ceremony which is conducted after declaration of the result.


